Season's Greetings!

The School Management extends warmest wishes for the ensuing festivals and takes this opportunity to thank all parents for their faith, support and motivation in these unprecedented times, during the Online Classes. Now as per guidelines of DOE, NCT Delhi vide Circular No. DE 23 (08)/SCH. Br./2021/611 dated 30.10.21, we intend to resume Offline Classes in a blended mode in a phased scheduled manner, for which following salient points are brought to your notice -

1. The school will ensure stringent adherence to the security and health protocols.
2. All teachers and staff are vaccinated.
3. The guidelines/ SOP issued by the Government/ DOE regarding COVID appropriate behaviour are being adhered to.

Please note for the month of **November, 2021:-**

1. Parents opting for a particular mode – either Offline or Online Classes - will not be permitted to change the option during the month. However, at the end of the month, an opportunity to update the Consent Form for December, 2021 will be given again.
2. As the students have now been away for school for more than 18 months and some of our tiny tots will be coming to school for the first time, in order to facilitate their smooth transition to Offline Classes, which commence from Monday, 15 November, 2021, each student, opting for Offline mode will visit school for 2 hours at least twice a week. The schedule for the Offline classes will be shared later however Online Classes will continue as per Time Table.
3. Students opting for Offline Classes must-
 - a. Carry the “duly signed Consent Form”. (Annexure 1)
 - b. Be in school uniform.
 - c. Wear school ID card / Carry temporary ID card.
 - d. Wear mask – 3 ply or surgical as per government norms, at all times.
 - e. Maintain social distancing at all times.
 - f. Carry lunch box, water bottle and all required books, stationery etc. as movement from allocated classroom / sharing will not be permitted.
 - g. Follow COVID Appropriate Behaviour (CAB) protocol set up by the Government.

Before sending your ward to school, please ensure that
