PARENTAL CIRCULAR Mode of Transportation (Session 2022-2023)

Dear Parent

Greetings of the day!

In continuation with earlier circulars on the School Website, please note the following:

- 1. Refer- W102 Classes III to XII Proposed School Bus Facility: The school transport would be started on trial basis for the month of April & May 2022. Parents of students who have opted for School Transport or still wish to opt for same can contact Transport Incharge at School Gate No 2 after their ward's Orientation Session.
- 2. Refer- W106 UKG to Class IX Orientation Session (2022-2023): In case you are unable to download the Google Form 'Undertaking to School regarding Mode of Transportation', Annexure 1 Undertaking for Mode of Transportation has been provided. A hard copy of either of the above is to be submitted to Class Teacher during your ward's Adaptation / Orientation Session.

It is once again reiterated and advised that you check the vehicle/van engaged by you in your personal capacity for ferrying your wards from their homes to school and back. Ensure that the vehicles comply with the directions issued by the Directorate of Education, Government of NCT of Delhi from time to time for safety and security of school students, while commuting to school and back. While doing so **the** parents must ensure that there is no use of illegal/ overloaded vehicle for transportation of their ward to and from school and that there is a lady attendant/ mother always present in the van in case of girl students.

Kindly co-operate with us in the interest of safety and security of your child to ensure strict compliance of the aforesaid guidelines.

Though the School takes necessary precautions at the School Gate for the safety of children, it is once again made clear that the School Management has no control over the conduct of the owners/drivers of private vehicles hired by you in your personal capacity.
