PARENTAL CIRCULAR Mode of Transportation (Session 2022-2023)

Dear Parent

Greetings of the day!

In continuation with earlier circulars on the School Website, please note the following:

1. Refer- W102 Classes III to XII - Proposed School Bus Facility: The school transport would be started on trial basis for the month of April & May 2022. Parents of students who have opted for School Transport or still wish to opt for same can contact Transport Incharge at School Gate No 2 after their ward's Orientation Session.
2. Refer- W106 UKG to Class IX Orientation Session (2022-2023): In case you are unable to download the Google Form 'Undertaking to School regarding – Mode of Transportation', Annexure 1 - Undertaking for Mode of Transportation has been provided. A hard copy of either of the above is to be submitted to Class Teacher during your ward's Adaptation / Orientation Session.

It is once again reiterated and advised that you check the vehicle/van engaged by you in your personal capacity for ferrying your wards from their homes to school and back. Ensure that the vehicles comply with the directions issued by the Directorate of Education, Government of NCT of Delhi from time to time for safety and security of school students, while commuting to school and back. While doing so **the parents must ensure that there is no use of illegal/ overloaded vehicle for transportation of their ward to and from school and that there is a lady attendant/ mother always present in the van in case of girl students.**

Kindly co-operate with us in the interest of safety and security of your child to ensure strict compliance of the aforesaid guidelines.

Though the School takes necessary precautions at the School Gate for the safety of children, it is once again made clear that the School Management has no control over the conduct of the owners/drivers of private vehicles hired by you in your personal capacity.

Annexure 1 - UNDERTAKING – Mode of Transportation (Session: 2022-2023)

In case our child

A. travels by **private cab/van**, we, hereby declare that we have ensured and checked. Please tick (✓)

- (a) the van / vehicle has valid commercial registration.
- (b) the police verification of the driver has been done. We will keep with us the driver's photo, his Mobile Number, photocopies of his Aadhaar Card, Driving Licence & Police Verification Report.
- (c) the driver carries his Driving Licence, R.C. of vehicle, Photo I-card, Aadhaar card and drops/picks our child at proper predefined place.
- (d) our child will be accompanied by one female parent/authorized female representative to ensure that the driver is disciplined and follows traffic rules.
- (e) the driver has a list/register containing details of Students Name with Father's Name, Address & Mobile Number.
- (f) the vehicle has a GPS system fixed and password available with parents, along with a First Aid Box and Fire Extinguisher.
- (g) the vehicle is fitted with one or more emergency buttons.
- (h) the vehicle has horizontal strip in the middle 150 mm wide, in gold-yellow colour on all sides.
- (i) the carrying capacity of the vehicle is limited to 1.5 (one and half) times the seating capacity. We will ensure that the cab is not overloaded.
- (j) van displays the board of 250 mm x 250 mm size with "SCHOOL CAB" inscribed with black letters on golden yellow background.
- (k) the driver wears grey colour uniform with name badge and PSV (Public Service Vehicle) badge and the driver carries a proper authorization card, containing the name, photograph and other such particulars as required.
- (l) the vehicle is properly maintained and serviced at regular intervals.

B. is dropped / picked in our **own car** and we certify that the credentials of driver have been duly verified.

C. Cycles / Walks to school, I will ensure that our child is safe during travel.

We also acknowledge that the school has been regularly updating us with safety guidelines issued by the Government from time to time regarding school travel.
