## Advisory for Parents using Private Vans

(Reference Public Notice issued by Transport Department, Govt. of NCT of Delhi)

Dear Parents

This is regarding the instructions issued by the Govt. of N.C.T. of Delhi and Delhi Police from time to time for ferrying students to and fro school. Safety and security of your ward is of prime importance to us. The School is making continual efforts to ensure the safety of our students and we seek the cooperation of parents in ensuring the same.

Since the catchment area of the school is Rohini, we recommend that for safety of your ward, parents discontinue the use of private vans and taxis and prefer use of supervised car pools instead.

However, if private vans and taxis are still being hired by parents for their ward, do ensure that,

### A) The Vehicle

1. Has a Commercial Number
2. CNG entered on Registration Certificate (RC).
3. Age of vehicle is not more than 15 years.
4. White coloured with horizontal strip of 150 mm width, golden yellow in colour in middle on all sides.
5. Display Board 25cm X 25cm 'School Cab' written.
6. Carrier on roof (for school bags).
7. List/Register containing details of students with Name, Father's Name, Address & Telephone/Mobile Numbers.
8. Capacity 1.5 times of the registered capacity only.
9. Speed governor with maximum speed of 40 km/hr.
10. Convex rear-view mirror on both sides.
11. First aid Box.
12. Fire extinguisher (dry powder type).
13. Name and address of permit holder painted / fixed on rear exterior of the vehicle.
14. Helpline No. 011-42-400-400 of Transport department displayed inside and outside.
15. Laminated police verification with Van No. written on it.
16. Amber flashing light affixed on all four top corners to be activated when cab stops.
17. GPS System and password available with you.

### B) The Driver should

1. Have a valid driving license and Police Verification Certificate
2. Wear grey uniform only with name plate PSV (Public Service Vehicle) badge.

### Please Do

1. Check/ follow the vehicle randomly to ensure that only the authorized person is driving the vehicle and is following all traffic rules.
2. Monitor the GPS system.
3. Maintain a copy of the driver's- Driving license, Police verification certificate and RC of vehicle.
4. Ensure that the vehicle is not overloaded.
5. Make sure that there is a **lady attendant/mother volunteer** always present in the van in case of girl students.

It is once again reiterated and advised that you check the vehicle/van engaged by you in your personal capacity for transporting your wards from their homes to school and back in order to ensure that the vehicles comply with the directions issued by the Directorate of Education, Government of NCT of Delhi from time to time for safety and security of school students, while commuting to school and back.

**Satisfy yourself about  
PERMIT CONDITIONS**



The School Cab shall have horizontal strip in the middle 150 mm wide, in gold-yellow colour on all sides

The carrying capacity of the School Cab be limited to  $1\frac{1}{2}$  (one and half) times the seating capacity

Van to display board of 250 mm x 250 mm size with "SCHOOL CAB" inscribed with black letters on golden yellow background

Should have a carrier on the roof for storage of school bags

Carry a register with details & address of students & school name with telephone nos.

The vehicle shall have approved speed control device "Electronic Speed Governor" to ensure speed limit of 40 km/hour

The vehicle shall be equipped with First Aid box, Fire Extinguisher and any other requirement specified

The driver shall wear grey colour uniform with nameplate and PSV (Public Service Vehicle) badge.  
No school cab shall ply unless its driver carries a proper authorization card, containing the name, photograph and other such particulars as directed
